### **Terms and Conditions**

## 1. Eligible Participants:

1. The JN Bank Everything You Do Could Be A Win For You With Your JN Bank Visa Credit Card Promotion is open to all:

a) Existing holders of a JN Bank Visa Classic or Gold Credit Card;

b) Persons who activate and spend using a JN Bank Visa Classic or Gold Credit Card during the Promotional Period, July 8 to August 31, 2024 ("the Promotional Period")

1.1. The Promotion is NOT open to any employee (this includes contractors, agents and affiliates) throughout the Jamaica National Group Limited ("JN Group") and its subsidiaries namely: JN Financial Group Limited, MCS Group Limited, JN Bank Limited, JN Small Business Loans Limited, JN Foundation, Management Control Systems Limited, Total Credit Services Limited, JN Finance Limited, JN Money Limited, JN General Insurance Company Limited, JN Life Insurance Company Limited, Jamaica Automobile Association (Services) Limited, JN Fund Managers Limited, JN Properties Limited, JN Real Estate Company Limited, Jamaica Popular Investment Company Limited and JN Cayman as well as members of their immediate families (that is, parents, siblings, spouse and children).

### 2. How to Enter:

2.1 For each month during the Promotional Period, persons who spend \$40,000¹ or more in aggregate (July and August) using their JN Bank Visa credit card will get a chance to win \$100,000

- 2.2 For each week during the Promotional Period, persons who spend any amount using their JN Bank Visa Credit Card will get a chance to win weekly prizes
- 3. The relevant rate of exchange governing any USD transaction on the relevant JN Bank Visa Credit Card will be the JN Bank Limited's "buying/selling" rate prevailing at the date of posting the relevant transaction. Transactions in other foreign currencies will not be eligible for entry.

### 4. Prizes

## Monthly prize

• A prize drawing will be held at the end of each month during the promotional period. At each drawing, two (2) persons will be randomly selected as winners of \$100,000, a total of four (4) winners during the promotion.

## **Weekly Prizes**

- Seven (7) persons will win weekly prizes for using their JN Bank Visa credit card
  - For the month of July 3 persons will win a Watch Kit for the greatest event of the summer (igloo and supermarket voucher) - One winner each week.
  - For the month of August, 4 persons will win a Dolphin Cove experience for two, for using their cards. One winner each week.

# 5. Method of selection of winners for all prizes and Prize Draw dates

- **5.1.** Ahead of each prize drawing, an Audit Command Language (ACL) database of the eligible participants will be compiled and forwarded to JN Bank's Internal Audit Department for verification and the electronic selection of potential winners (the database).
  - In the database, each person who spends any amount using their JN Bank Visa Credit Card weekly or who spend \$40,000 or more in aggregate each month will be entered for the relevant weekly or monthly prize draw.
- **5.2.** For the monthly prizes, one potential winner and twenty backup potential winners will be selected at random from the database of persons who met the monthly spend in the relevant month.
- **5.3.** A representative from the Betting, Gaming and Lotteries Commission ("the BGLC") reserves the right to attend the draw and a member from JN Bank's Internal Audit Department will oversee the drawing of prizes in this Promotion.
- 5.4. On each prize draw date, the potential winners for the respective dates will be contacted by telephone, notified of the prize they have the chance to win and invited to complete the "test of skill" to win it. For the "test of skill" the potential winner will be given the first two words "We'll Help ..." by JN Bank's representative, and the potential winner will be required to say "...You Find A Way." Each potential winner will have one chance to answer correctly. Upon successful recitation of remaining words of the tagline, the potential winner will be declared a winner.
- **5.5.** Persons will be notified on the outlined draw dates.
