Terms and Conditions JN Bank Limited ("JN Bank") Billion Dollar Club Promotion

Properties Limited, JN Real Estate Company Limited, Jamaica Popular Investment Company Limited and JN Cayman as well as members of their immediate families (that is, parents, siblings, spouse and children).
- 1.2 Each individual who refers a Proposed Mortgagor (i.e. a person interested in obtaining a mortgage to purchase a property) to JN Bank that results in a successful mortgage loan (a mortgage loan application that is approved and disbursed by the JN Bank) will be eligible to receive an incentive payment as well as an opportunity to win a prize in the JN Bank "Billion Dollar Club Promotion" Grand Prize Drawing..
