## PROMOTION TRAVELERS' EDITION TERMS AND CONDITIONS

### Promotion Period:

JN Savings DreamZ Promotion: Travelers' Edition  
- Promotion period: January 15, 2025 - December 31, 2025

### Promotion Account Opening Period

To qualify for the JN Savings DreamZ Promotion, an account must be opened during the six-month period between January 15, 2025 – June 30, 2025.

### Participation Criteria

JN Group Staff are not qualified to enter this promotion.

### Mechanics:

#### 1. Account Opening Details

a) To participate in this Promotion, new or existing members must open one or more of the (JN Bank High Yield) contractual savings account during the promotion period in any of the following currencies outlined below:

- i. JMD account
- ii. USD account
- iii. CDN account
- iv. GBP account

b) The account opening period runs from January 15, 2025 – June 30, 2025

c) The promotion account must be opened with a minimum deposit of:

- i. Contractual savings accounts (JN Bank High Yield)
  - i. Fifteen Thousand Jamaican Dollars (\$15,000.00) and/or One Hundred (100) units of foreign currency including United States Dollars (USD), Canadian Dollars (CDN) or British Pound Sterling (GBP) during the promotion account opening period.

#### 2. Monthly Pledge Payments (Contractual Savings Account)

a. #### 6. Exchange Rate

- a) The relevant rate of exchange governing any deposit/credit to the promotion account will be established by reference to the relevant exchange rate published by the Treasury Management Unit of the Bank on the date of deposit.

#### 7. Method of selection of winners for all prizes:

- a. Potential winners will be selected randomly using the Audit Command Language software (ACL) and will be contacted by a JN Bank representative to complete the JN Bank's tagline "We'll Help You Find A Way". The two words "We'll Help..." will be said by the JN Bank representative and the potential winner will be required to say "...You Find A Way".
